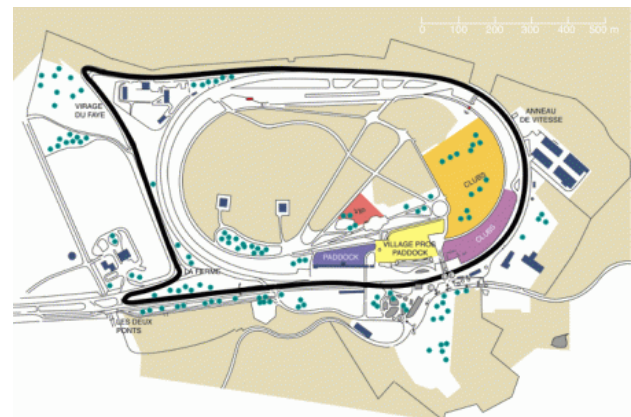

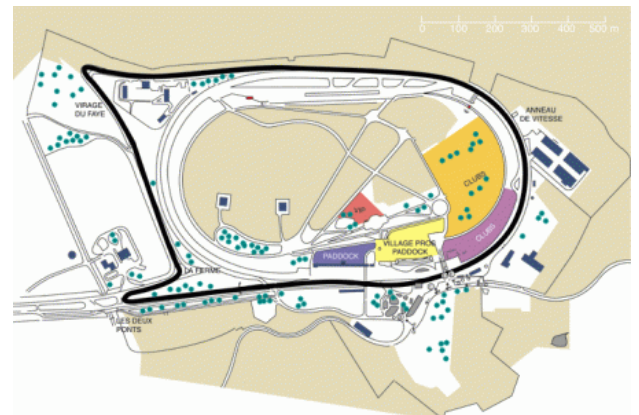

## RULES & CONDITIONS GOVERNING ACCESS TO THE RACING TRACK

### Riders & Passengers Code of Conduct

- Only properly filled in registration forms with all the support documentation required will be taken into consideration.
- The organiser reserves the right and keeps its discretionary powers to dismiss any registration that may be in contradiction with the spirit of the event or its contents as intended by the organiser.
- No registration will take place on the day and concurrently we reserve the right to remove any person whose behaviour is deemed to be inappropriate or dangerous on the site.
- Only pre-1965 bikes may be ridden on the circuit. Post-1965 bikes are solely for exhibition purposes.
- If the participant cancels once the registration has been validated by the organiser, no refund will be made.
- Rides on the circuit are to be at moderate speed, without timing and/or classification

### Registration Fee

- The registration fee of €75 per rider and bike includes the day's riding and a lunch hamper. This fee is in application until 1st March 2012. From 2<sup>nd</sup> March 2012, the applicable fee will be €85. No more registration will be accepted from 1st May 2012. No registration will be accepted on the day of the event (visitor, exhibitor, rider, assistant).
- The registration fee of €12 for persons assisting, visitors & bike exhibitors include only access on the racing complex. Persons assisting, visitors & bike exhibitors are not allowed to ride the bikes. The €18 lunch hamper is an optional extra to be ordered at the time of registration.
- No registration will be accepted on site.

**BYO PICNICS ARRANGEMENTS ARE NOT ALLOWED**

### Protocol & Conditions of Participation

To partake in the event, every participant :

- Must register a bike and receive written confirmation and approval of the registration by the organiser.
- Arrange total roadworthiness of the bike to the rules in place at the time of the event (except for racing models).
- Must make sure of the good working order of the registered bike and of the good state of repair of its equipment.
- Must be in possession of all statutory & compulsory documents pertaining to the registered bike (registration certificate, insurance certificate et rider's permit and or licence). It is also to be verified that the insurance policy covers this type of activity.

### At the Site

- Entry is only open at the scheduled times.
- Please be familiar and respect the rules of the circuit.
- Any damage caused to the assets of the racing circuit will be payable by the perpetrator of the damage.
- The organiser reserves the right to control or delegate control towards the respect of all these conditions at any time.

- **Animals are strictly forbidden on the site.**
- Please be sure that your bike has a full tank prior to accessing the site as no pass out for any exit will be issued and there are no filling up facilities on site.
- On the site, **the trading of parts, fire & barbecue, erection of a tent, alcoholic drinks & BYO picnic are strictly forbidden** by the site owner (UTAC).

### **Schedule of the Day**

- Morning session: Check-in from 7:30 AM to 9:00 AM with Compulsory Briefing at 8:45AM followed by Series Rides from 9:00 AM to. Grand Parade schedule at around 11:30 AM.
- Afternoon session: after the 12:00 PM to 2:00 PM lunch break, the Series Rides will resume from 2:00 PM to 5:00 PM.

### **Personal Commitment towards UTAC (Racing Complex Managers) and the Organiser**

- Every participant commits to have his/her bike prepared in accordance with the governing laws and rules and he/she declares that only his/her responsibility is engaged in case of non respect of the governing laws and rules. He/she commits to strictly obey the rules as well as the entire terms of this agreement. Any damage caused to the assets of the site is the sole responsibility of the perpetrator. Every participant agrees to his/her registration to be a personal engagement and with the full knowledge and understanding of risks associated with this type of activity. He/she declares to have been made aware and fully understand the conditions of participation and he/she commits to strictly obey these conditions.
- Every participant discharges **UTAC** and **Terrot Club de Ballancourt** of any responsibility. It further forfeits, in case of an incident whichever it may be, any claim against UTAC or Terrot Club de Ballancourt and their respective insurers.
- Every participant declares that he/she will subscribe at his/her own expense, to an insurance policy with a company reputed to be solvent, to cover any risk that may be incurred within the context of this event.
- Furthermore, every participant declares that he/she will settle any invoice raised by UTAC in regards to damages caused to its assets by the participant.
- Every participant agrees to be photographed and/or recorded in movies by the organiser, the organising agency, or any other organisation or person authorised by the organiser on the day, for promotional purposes. Every participant agrees also to the use of his/her image & his/her voice by the organiser or any authorised person or organisation for the purpose of promotion on any media platform. Every participant forfeits all claims to receive any form of remuneration to grant this authorisation.
- The sending of this registration form confirms the irrevocable acceptance and without reservation of all these conditions.
